1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 140 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's governance arrangements:

- Assertion 2 – The Council states that it maintained an adequate system of internal control. Controls over arrangements for making payments are an essential part of the system of internal control. The Council did not provide sufficient information for me to draw a conclusion about the adequacy of its arrangements.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Approval of the annual return

The Council approved its Annual Governance Statement before receiving the Internal Audit report. The Internal Audit report is an important element of the assurance the Council receives over its system of internal control that its reports on in the Annual Governance Statement. When approving the Annual Governance Statement, the Council lacked the evidence to support its assertions. We recommend that for 2021-22 onwards, the Council receives and considers the Internal Audit report before it approves its Annual Governance Statement.

There are no further matters or recommendations that I wish to draw to the Council's attention.
